

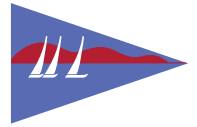

## AGREEMENT:

I understand that sailing is a sport that involves risk such as injury, loss or damage. I understand that as a member I share the responsibility for safety and agree to practice safe boating. I agree not to sue and agree to hold harmless the Utah Lake Yacht Club Inc. (hereinafter referred to as "the Club"), it's agents, officers, employees and other members from all claims of injury or loss to person or property arising from my participation in the Club Inc. activities.

I hereby give permission to the club to use my photograph or likeness in any club promotional material and website.

I understand that the club recommends that all members supply their own Coast Guard Approved personal flotation device (PFD). I understand that the club encourages members and guests to wear a PFD whenever boating.

I agree to always wear a PFD during club racing and also while sailing with strong wind, bad weather or darkness approaching.

I agree not to go sailing on any boat or with any crew that I believe to be unsafe.

I agree that it is my sole responsibility to decide when to go sailing.

I understand that all boats must maintain a proper lookout at all times and must avoid any and all collisions (regardless of right of way), grounding and equipment loss or damage. I understand that club members sailing are collectively and equally responsible for reimbursing the club for damage or loss sustained while using a club boats. Equipment losses such as winch handles overboard etc. are the full responsibility of the responsible party.

Membership has a minimum term of 12 months. Member may cancel this agreement with 30 day written notice at anytime. Membership dues is non refundable. The Club reserves the right to cancel any membership by sending 30 day written notice to member.

## Service:

Club members are expected to perform twenty hours of service annually. Service hours must be approved by a Flag Officer. Service hours must be completed prior to applying to be a Captain or Boat Sponsor.

## DUES:

Annual membership dues is \$100. Annual Student\* membership dues is \$50. Non members may participate in a club events by paying a \$10 fee. This fee will be applied towards their membership dues. Individuals under the age of 14 may participate for free in club events when accompanied by a club member.

\* A Student is defined as an individual between the age of 14 and 25, and enrolled in school.

Membership dues should be paid primarily to the club Purser. Club officers are the only people who may accept funds on behalf of ULYC. Officers who receive funds will turn funds over to the club Purser.

## PRIVILEGES:

Club members in good standing have following privileges:

- Voting rights
- Use of club boats
- The ability to sponsor boats
- The ability to become captain of a boat
